## BAC RESOLUTION NO. 01 -2019

## RESOLUTION RECOMMENDING, BY REFERENDUM, AWARDING THE CONTRACT FOR THE PROCUREMENT OF SECURITY SERVICES FOR THE EMBASSY OF THE REPUBLIC OF THE PHILIPPINES IN PHNOM PENH, CAMBODIA

WHEREAS, the Embassy of the Republic of the Philippines in Phnom Penh, Cambodia, (hereinafter referred to as the "Embassy"), requires round-the-clock security services to ensure the protection of its premises, and safety of its personnel and the transacting public.

**WHEREAS,** in view of the implementation of tighter security measures at the Embassy, the Bids and Awards Committee (BAC) has deemed it necessary to continue engaging the services of a private security agency;

WHEREAS, the Embassy's Annual Procurement Plan (APP) for 2019 includes the procurement of security services for the Embassy;

WHEREAS, the BAC has requested price quotations from three (3) reputable security agencies and received two (2) quotations, as follows:

WHEREAS, after careful consideration of the said quotations, the BAC has identified MPA International Ltd. as the service provider that submitted the lowest responsive and most responsive quotation for the required security services for the Embassy, in the amount of Nine Hundred Twenty Four Dollars only (US\$ 924.00) per month;

WHEREAS, Section 52 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided
