RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE  
PROCUREMENT OF PRINTING SERVICES FOR INVITATION CARDS AND  
ENVELOPES FOR THE OFFICIAL USE OF THE EMBASSY TO VANN SOPHEA  
PRINTING HOUSE

**WHEREAS**, the Embassy of the Republic of the Philippines in Phnom Penh, Cambodia, hereinafter referred to as the "Embassy", intends to procure printing services for 500 pieces of invitation cards and envelopes for its official use:

**WHEREAS**, the Embassy's Annual Procurement Plan (APP) for 2019 includes the procurement of printing services for the official use of the Embassy;

**WHEREAS**, the Embassy has requested and received price quotations from three (3) reputable suppliers, as follows:

Phnom Penh Printing House	US\$ 650.00
Kim Heng T-shirt Printing-Rubber Stamp	US\$ 575.00

**WHEREAS**, after careful consideration of these quotations, the BAC has identified Vann Sophea Printing House as the supplier that submitted the lowest responsive and most favorable quotation for printing services of 500 pieces of invitation cards and envelopes for the Embassy's use, in the amount of **Three Hundred Forty Dollars only (US\$340.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00).

**NOW THEREFORE**, we, the members of the Bids and Awards Committee of the Embassy, RESOLVE to RECOMMEND to the Head of Procuring Entity, the award of the contract for the procurement of printing services of 500 pieces of invitation cards and envelopes for the official use of the Embassy, in favor of Vann Sophea Printing House, in the amount of **THREE HUNDRED FORTY DOLLARS ONLY (US\$340.00)**


