**RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE
CONTRACT FOR LEASE OF VENUE FOR THE OFFICIAL USE OF THE
EMBASSY DURING THE CONSULAR OUTREACH MISSION**

WHEREAS, the Embassy of the Republic of the Philippines in Phnom Penh, Cambodia, hereinafter referred to as the "Embassy," intends to conduct consular outreach mission in Borey Phipop Thmey, a suburb located in the outskirts of Phnom Penh, on 03 February 2019;

WHEREAS, the Embassy's Annual Procurement Plan (APP) for 2019 includes the rent of venue for the Embassy's official activities;

WHEREAS, Borey Phipop Thmey is a residential community that has limited available venues appropriate for the Embassy's consular activity;

WHEREAS, after diligently searching for an appropriate venue, the Embassy has identified the El Dream International School for its consular outreach, with a rental price of **Ninety Dollars only (US\$90.00)**;

WHEREAS, Section 53.10 of the Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Report Act of 2009, allows an agency to resort to Lease of Real Estate/Venue.

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, **RESOLVE** to **RECOMMEND** to the Head of Procuring Entity the award of the contract for the lease of venue for the official use of the Embassy, in favor of El Dream International School, in the amount of **NINETY DOLLARS ONLY (US\$90.00)**.
