## BAC Resolution No. 09 - 2019

## RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE CONTRACT FOR SURVIVAL KHMER LANGUAGE TRAINING FOR NEWLY-ARRIVED FILIPINOS IN CAMBODIA

WHEREAS, the Embassy of the Republic of the Philippines in Phnom Penh, Cambodia (hereinafter referred as the "Embassy") intends to procure training services for twenty (20) hours of Khmer language lessons for newly-arrived Filipinos in Cambodia;

**WHEREAS**, the language training will equip newly-arrived OFWs in Cambodia to adjust to the society and better protect their rights and welfare;

WHEREAS, the Embassy sought and received authority from the DFA- Office of the Undersecretary for Migrant Workers Affairs (NP-24-OUMWA-2019 dated 29 January 2019) to disburse funds for the conduct of 20 hours of Khmer language training for newly-arrived Filipinos in Cambodia, chargeable against ATN Funds;

**WHEREAS**, the Embassy has requested and received price quotations from several reputable schools as follows:

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Report Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00).
