RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE
CONTRACT FOR THE PROCUREMENT OF DRINKING WATER
TO SL HI TECH CO. LTD.

WHEREAS, the Embassy of the Republic of the Philippines in Phnom Penh, Cambodia (hereinafter referred as the "Embassy") intends to procure safe drinking water for its official use, particularly for personnel, clients and guests;

WHEREAS, the Annual Procurement Plan (APP) for 2019 of the Embassy of the Philippines in Phnom Penh, includes water expenses;

WHEREAS, the Embassy has requested and received price quotations from three (3) reputable suppliers, as follows:

WHEREAS, after careful consideration of these quotations, the Embassy has identified SL Hi Tech Co., Ltd. as the provider that submitted the lowest responsive and most favorable quotation for the Embassy's use, in the amount of **Four Dollars (US\$4.00)** per unit of 20 liter bottle and a box of 350 ml drinking water;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Report Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00).

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, **RESOLVE** to **RECOMMEND** to the Head of Procuring Entity the award of a contract for the year-long procurement of drinking water, in favor of SL Hi Tech Co., Ltd., in the amount of **FOUR DOLLARS (US\$4.00)** per unit of 20 liter bottle and a box of 350 ml drinking water.
