RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE
CONTRACT FOR PEST AND TERMITE CONTROL TREATMENT OF THE
EMBASSY TO ANTITERMITE CO. LTD.

WHEREAS, the Philippine Government owns the property where the Chancery of the Embassy of the Republic of the Philippines in Phnom Penh, hereafter called the "Embassy," is currently located;

WHEREAS, prudent management of government-owned assets require that the property and the buildings within its premises undergo regular pest and termite control treatment in order to prevent infestation, protect existing structures from deterioration, and maintain personnel's safety and health;

WHEREAS, the Embassy's Annual Procurement Plan (APP) for 2019 includes expenses for environment and sanitary services of the Embassy;

WHEREAS, the Embassy requested quotations from three reputable companies and received one (1) price quotation, as follows:

WHEREAS, after careful consideration of the said quotation, the BAC has identified Antitermite Co. Ltd. as the company that submitted the single calculated and responsive and favorable quotation, in the amount of **Ninety Dollars (US\$90.00)** monthly for pest control and **Four Hundred Fifty Dollars (US\$450.00)** annually for termite control, exclusive of 10% VAT;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00).

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, **RESOLVE** to **RECOMMEND** to the Head of Procuring Entity, the award of the contract for the pest and termite control treatment of the Embassy, in favor of Antitermite Co. Ltd., in the amount of **NINETY DOLLARS (US\$90.00)**

annually for termite control, exclusive of 10% VAT.


