BAC Resolution No. 14 - 2019

RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE CONTRACT FOR THE REPAIR AND MAINTENANCE OF FOUR (4) UNITS OF CCTV CAMERAS OF THE EMBASSY TO VEASNA COMPUTER 3 & SECURITY CAMERA

WHEREAS, four (4) units of Embassy's CCTV cameras with property numbers NP-07-01-10-16; NP-07-01-11-16; NP-07-01-13-16; and NP-07-01-29-16 (all found at station), encountered mechanical problems on 01 March 2019, requiring repairs by a qualified technician.

WHEREAS, the Annual Procurement Plan (APP) for 2019 of the Embassy of the Philippines in Phnom Penh, includes the procurement of repair and maintenance work for the fixtures of the Embassy;

WHEREAS, the Embassy requested and received quotations from three (3) different qualified repair shops for the abovementioned repair works, as follows:

WHEREAS, after careful consideration of these quotations, the Embassy has identified Veasna Computer 3 & Security Camera as the company that submitted the lowest responsive quotation for the required repairs, with the price quotation of One Hundred Thirty Dollars only (US\$130.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00);

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, RESOLVE to RECOMMEND to the Head of the Procuring Entity the award of the contract for the procurement of repair and maintenance service for the Embassy's four units of CCTV cameras with property numbers NP-07-01-10-16; NP-07-01-11-16; NP-07-01-13-16; and NP-07-01-29-16, in favor of Veasna Computer 3 & Security Camera, in the amount of ONE HUNDRED THIRTY DOLLARS ONLY (US\$130.00).
