**RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE
CONTRACT FOR THE REPAIR OF A CLOGGED TOILET BOWL OF THE
EMBASSY TO A1 SEWER & PLUMBING**

WHEREAS, the toilet bowl located at the Female Toilet for consular clients was clogged on 17 March 2019 during the Sunday Consular Services of the Embassy, requiring repair by a qualified plumber;

WHEREAS, the Annual Procurement Plan (APP) for 2019 of the Embassy of the Philippines in Phnom Penh, includes the procurement of repair and maintenance work for the fixtures of the Embassy;

WHEREAS, the Embassy requested and received quotations from three (3) different qualified shops for the abovementioned repair work, as follows:

COMPANY NAME	QUOTED PRICE
A1 Sewer & Plumbing	US\$60.00
Teams Cambodia	US\$104.50
AAQ Service	US\$80.00

WHEREAS, after careful consideration of these quotations, the Embassy has identified A1 Sewer & Plumbing as the company that submitted the lowest responsive quotation for the required repair, with the price quotation of **Sixty Dollars only (US\$60.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00);

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, **RESOLVE** to **RECOMMEND** to the Head of the Procuring Entity the award of the contract for the procurement of repair and maintenance service for the Embassy's clogged toilet bowl, in favor of A1 Sewer & Plumbing, in the amount of **SIXTY DOLLARS ONLY (US\$60.00)**.






