BAC Resolution No. 24 - 2019

RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE CONTRACT FOR THE SHIPMENT BY SEA OF THE PERSONAL EFFECTS AND HOUSEHOLD GOODS OF AMBASSADOR CHRISTOPHER B. MONTERO FROM CAMBODIA TO BRUNEI DARUSSALAM

WHEREAS, Ambassador Christopher B. Montero (hereinafter referred to as "Ambassador") will be cross-posted to the Philippine Embassy in Brunei under Assignment Order No. 159-2019 dated 25 March 2019;

WHEREAS, the Ambassador will be shipping his personal effects and household goods by sea from Phnom Penh, Cambodia to Bandar Seri Begawan, Brunei;

WHEREAS, through fax no. NP-88-OFMS-2019 dated 29 April 2019, OFMS transmitted ORS No. 2019-04-003502 dated on the same day authorizing the payment of PhP 336,098.84 (US\$6,419.00 at PhP 52.36) for the sea shipment of personal effects (US\$5,500.00) and plane fare (US\$919.00) of the Ambassador;

WHEREAS, the Embassy has requested and received price quotations from three (3) reputable forwarding companies, as follows:

WHEREAS, after careful consideration of these quotations, the Embassy has identified Trans-link Cambodia Ltd. as the company that submitted the lowest responsive and most favorable quotation for the shipment of the Ambassador's personal effects, in the amount of **Five Thousand and Five Hundred Dollars only (US\$5,500.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00);

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, **RESOLVE to RECOMMEND** to the Head of the Procuring Entity the award of the contract for the sea shipment of the Ambassador's personal effects, in
