**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE
PROCUREMENT OF CATERING SERVICES FOR THE EMBASSY'S FLAG
RAISING CEREMONY AND TRADITIONAL BREAKFAST WITH THE FILIPINO
COMMUNITY IN CELEBRATION OF THE 121ST ANNIVERSARY OF THE
PROCLAMATION OF PHILIPPINE INDEPENDENCE**

WHEREAS, the Embassy of the Republic of the Philippines in Phnom Penh (hereinafter referred to as "Embassy") intends to procure catering services for its flag raising ceremony and the traditional breakfast with the Filipino community on 12 June 2019, in celebration of the 121st Anniversary of the Proclamation of Philippine Independence, which will be attended by approximately 100 invited guests;

WHEREAS, the Embassy's Annual Procurement Plan (APP) for 2019 includes expenses for the 121st Independence Day Celebration;

WHEREAS, the Embassy has requested and received quotations from the following three (3) reputable companies:

COMPANY NAME	QUOTED PRICE
Garden Restobar	US\$ 6.00 per person (set meal with drinks)
Master Tapsi	US\$ 5.75 per person (set meal with drinks)
MJ Carenderia	US\$ 6.00 per person (set meal with drinks)

WHEREAS, after careful consideration of these quotations, the Embassy has identified Master Tapsi as the company that submitted the most favorable proposal for catering services for the event, in the amount of **Five Dollars and Seventy-Five Cents only (US\$5.75)** per person and for an estimated 100 guests;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00);

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, **RESOLVE** to **RECOMMEND** to the Head of the Procuring Entity the award of the contract for the procurement of catering services for the Embassy's flag raising ceremony and traditional breakfast with the Filipino community to Master Tapsi, in the amount of **FIVE DOLLARS AND SEVENTY-FIVE CENTS ONLY (US\$5.75)** per person and for an estimated 100 guests.


