BAC Resolution No. 31 - 2019

RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE CONTRACT FOR THE LEASE OF VEHICLE FOR THE TRANSPORTATION OF THE PHILIPPINE MADRIGAL SINGERS

WHEREAS, the Embassy of the Republic of the Philippines in Phnom Penh, Cambodia, hereinafter referred to as the "Embassy," intends to invite the Philippine Madrigal Singers in Phnom Penh, Cambodia on 5-8 June 2019 in celebration of the 121st Philippine Independence Day;

WHEREAS, the twenty-five (25) members of the Philippine Madrigal Singers will require transportation within Phnom Penh, Cambodia for four (4) days;

WHEREAS, the Embassy's Annual Procurement Plan (APP) for 2019 includes expenses for the 121st Philippine Independence Day celebration;

WHEREAS, the Embassy has requested and received price quotations from three (3) reputable companies, as follows:

Eternal Asia Travel & Tours	US\$350.00 + US\$20/ hour overtime
Int-Cheav Group C. Ltd.	US\$380.00 + US\$15/ hour overtime

WHEREAS, after careful consideration of these quotations, the Embassy has identified Sophiya Tours as the company that submitted the lowest responsive and most favorable quotation for the lease of vehicle for the transportation of the Philippine Madrigal Singers, in the amount of **Three Hundred Fifteen Dollars only (US\$315.00)** for four (4) days, excluding overtime, if any;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00);

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, **RESOLVE** to **RECOMMEND** to the Acting Head of the Procuring Entity the award of the contract for the lease of vehicle for the transportation of the Philippine Madrigal Singers, in favor of Sophiya Tours, in the amount of **THREE HUNDRED FIFTEEN DOLLARS ONLY (US\$315.00)** for four (4) days, excluding overtime, if any.
