**RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE CONTRACT FOR THE PRINTING OF BANNERS AND SOUVENIR PROGRAMS FOR THE PUBLIC PERFORMANCE OF THE PHILIPPINE MADRIGAL SINGERS**

**WHEREAS**, the Embassy of the Republic of the Philippines in Phnom Penh, Cambodia, hereinafter referred to as the "Embassy," intends to print the banners and souvenir programs required for the public performance of the Philippine Madrigal Singers at the Chaktomuk Theater Hall in Phnom Penh, Cambodia on 06 June 2019 in celebration of the 121<sup>st</sup> Philippine Independence Day;

**WHEREAS**, the Embassy's Annual Procurement Plan (APP) for 2019 includes expenses for the 121<sup>st</sup> Philippine Independence Day celebration;

**WHEREAS**, the Embassy identified the following items to be printed:

**WHEREAS**, the Embassy has requested and received price quotations from three (3) reputable companies, as follows:

**WHEREAS**, after careful consideration of these quotations, the Embassy has identified Den Printing as the company that submitted the lowest responsive and most favorable quotation for the printing of banners and souvenir programs required for the public performance of the Philippine Madrigal Singers, in the amount of **Two Hundred Forty Five Dollars and Fifty Cents only (US\$245.50)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00);
