**RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE PROCUREMENT OF TWO (2) UNITS OF PRINTER FOR THE OFFICIAL USE OF THE EMBASSY TO APSARA BUSINESS SOLUTIONS CAMBODIA CO. LTD.**

**WHEREAS**, the Embassy of the Republic of the Philippines in Phnom Penh, Cambodia, hereinafter referred to as the "Embassy," intends to procure two (2) units of printers for the official use of the Embassy;

**WHEREAS**, the Embassy's Annual Procurement Plan (APP) for 2019 includes expenses for ICT equipment;

**WHEREAS**, the Embassy has requested and received price quotations from three (3) reputable suppliers as follows:

**WHEREAS**, after careful consideration of these quotations, the Embassy has identified Apsara Business Solutions Cambodia Co., Ltd. as the company that submitted the lowest responsive and most favorable quotation for the procurement two (2) units of printer for the official of the Embassy, in the amount of **Two Hundred Forty Two Dollars only (US\$242.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00);
