RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE CATERING SERVICES CONTRACT FOR THE VOICE WORKSHOP BY THE PHILIPPINE MADRIGAL SINGERS IN COMMEMORATION OF THE 121ST ANNIVERSARY OF THE PROCLAMATION OF PHILIPPINE INDEPENDENCE

WHEREAS, the Embassy of the Republic of the Philippines in Phnom Penh (hereinafter referred to as "Embassy") intends to procure catering services for the Voice Workshop by the Philippine Madrigal Singers on 08 June 2019 to commemorate the 121st Anniversary of the Proclamation of Philippine Independence;

WHEREAS, the Embassy expects an attendance of approximately sixty (60) participants;

WHEREAS, the Embassy's Annual Procurement Plan (APP) for 2019 includes expenses for the 121st Independence Day Celebration;

WHEREAS, the Embassy has requested and received quotations from the following three (3) reputable companies:

WHEREAS, after careful consideration of these quotations, the Embassy has identified Cecille Campo as the company that submitted the most favorable catering services proposal for the event, in the amount of **Three Hundred Dollars only (US\$300.00)** for an estimated 60 participants;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00);

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, **RESOLVE** to **RECOMMEND** to the Acting Head of the Procuring Entity the award of the contract for the procurement of catering services for the Voice Workshop by the Philippine Madrigal Singers in favor of Cecille Campo, in the amount of **THREE HUNDRED DOLLARS ONLY (US\$300.00)** for an estimated 60 participants.


