RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE
CONTRACT FOR THE REPAIR AND MAINTENANCE OF ONE (1) UNIT OF
PHOTOCOPYING MACHINE OF THE EMBASSY TO APSARA BUSINESS
SOLUTIONS CAMBODIA CO. LTD.

WHEREAS, one (1) photocopying machine under the Embassy's property inventory, with number NP 01-09-01-17, encountered mechanical problems on 11 June 2019, requiring necessary and urgent repair;

WHEREAS, the Annual Procurement Plan (APP) for 2019 of the Embassy of the Philippines in Phnom Penh, includes the procurement of repair and maintenance work for the office equipment of the Embassy;

WHEREAS, the Embassy requested and received quotations from three (3) different qualified repair shops for the abovementioned repair works, as follows:

WHEREAS, after careful consideration of these quotations, the Embassy has identified Apsara Business Solutions Cambodia Co. Ltd. as the company that submitted the lowest responsive quotation for the required repairs, in the amount of **Three Hundred Nine Dollars only (US\$309.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00);

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, **RESOLVE** to **RECOMMEND** to the Acting Head of the Procuring Entity the award of the contract for the repair and maintenance service of one (1) unit of photocopying machine with property number NP 01-09-01-17, in favor of Apsara Business Solutions Cambodia Co. Ltd., in the amount of **THREE HUNDRED NINE DOLLARS ONLY (US\$309.00)**.


