BAC Resolution No. 39 - 2019

RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF AN ANNUAL MEDICAL INSURANCE POLICY COVERAGE FOR MS. ERLIN A. ROBLES, LOCALLY-HIRED FILIPINO EMPLOYEE OF THE PHILIPPINE EMBASSY IN PHNOM PENH

WHEREAS, the Embassy of the Republic of the Philippines in Phnom Penh, Cambodia (hereinafter referred to as the "Embassy") engaged the services of Ms. Erlin A. Robles, Filipino national, as a locally-hired employee for the position of Receptionist/Assistant;

WHEREAS, Section 7 (Health Care Benefits) of the Contract of Employment dated 24 June 2019 between the Embassy and Ms. Robles stipulates that "The Second Party (Ms. Robles) shall be entitled to health care benefits as provided under the Labor Code of Cambodia," which includes medical insurance coverage;

WHEREAS, the approved budget for the health care insurance of Ms. Robles is \$755.00 per annum;

WHEREAS, the medical insurance premiums of Ms. Robles is chargeable against the Embassy's available allotment for Personnel Services (PS) for locally-hired Embassy staff;

WHEREAS, the Embassy has requested price quotations for the annual medical insurance coverage from the period covering 01 July 2019 through 30 June 2020 from four (4) reputable insurance providers and received only one (1) proposal, as follows:

WHEREAS, after careful consideration of the said quotation, the BAC has identified Forte Insurance as the service provider that submitted the single calculated and most responsive quotation for the annual medical insurance policy coverage of Ms. Robles, in the amount of Seven Hundred and Fifty-Five Dollars only (US\$ 755.00), including administrative fees;

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, RESOLVE to RECOMMEND to the Acting Head of the Procuring Entity (HOPE) the award of the contract for the procurement of the annual medical insurance policy coverage for Ms. Erlin A. Robles, a locally-hired Filipino staff of the Embassy, in favor of Forte Insurance, which submitted the single and most responsive quotation in the amount of **SEVEN HUNDRED AND FIFTY-FIVE DOLLARS ONLY (US\$ 755.00)**, including administrative fees.
