RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE
CONTRACT FOR THE CLEANING AND MAINTENANCE OF AIR CONDITIONING
UNITS OF THE EMBASSY TO AUN SITHA

WHEREAS, the air conditioning units of the Embassy require regular cleaning and maintenance services in order to ensure that these remain in good working condition and maintain a healthy indoor air quality for the Embassy personnel and the transacting public;

WHEREAS, the Embassy's Annual Procurement Plan (APP) for 2019 includes the procurement of repair and maintenance work for the fixtures and furniture of the Embassy;

WHEREAS, the Embassy has requested and received price quotations from three (3) reputable suppliers, as follows:

Aun Sitha	US\$ 220.00
Oun Bory	US\$ 330.00
Seng Huth	US\$ 286.00

WHEREAS, after careful consideration of these quotations, the Bids and Awards Committee has identified Aun Sitha as the company that submitted the lowest responsive and most favorable quotation for the required service, with a price quotation of **Two Hundred and Twenty Dollars only (US\$220.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00);

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, **RESOLVE** to **RECOMMEND** to the Acting Head of the Procuring Entity, the award of the contract for the cleaning and maintenance of the Embassy's air conditioning units, in favor of Aun Sitha, in the amount of **TWO HUNDRED AND TWENTY DOLLARS ONLY (US\$220.00)**.
