RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE
PROCUREMENT OF PRINTER INK CARTRIDGES FOR THE OFFICIAL USE OF

WHEREAS, the Embassy of the Republic of the Philippines in Phnom Penh, Cambodia, hereinafter referred to as the "Embassy", intends to procure common computer supplies for its official use, particularly printer ink cartridges:

WHEREAS, the Embassy's Annual Procurement Plan (APP) for 2018 includes the procurement of common computer supplies intended solely for the official use of the Embassy;

WHEREAS, the Embassy has identified the following common computer supplies to be purchased to replenish the existing inventory of these essential items for its daily office operations:

WHEREAS, the Embassy has requested and received price quotations from three (3) reputable suppliers, as follows:

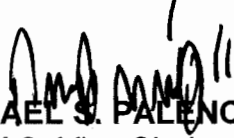
WHEREAS, after careful consideration of these quotations, the BAC has identified The Light (D'Light) Stationery as the supplier that submitted the lowest responsive and most favorable quotation for printer ink cartridges for the Embassy's use, in the amount of **One Hundred Sixty-Four Dollars only (US\$164.00)**;

WHEREAS, Section 52 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Shopping provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00).

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, RESOLVE to RECOMMEND to the Head of Procuring Entity the award of the contract for the procurement of printer ink cartridges for the official use of the Embassy, in favor of The Light (D'Light) Stationery, in the amount of **ONE HUNDRED SIXTY-FOUR DOLLARS ONLY (US\$164.00)**.

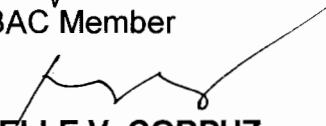

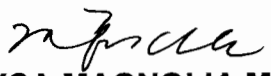
