RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF THE
CONTRACT FOR REPAIR OF THE KITCHEN DRAINAGE OF THE EMBASSY TO
A1 SEWER AND PLUMBING

WHEREAS, the drainage located at the kitchen of the Embassy was clogged on 19 March 2018 due to grease build-up and the decrepit condition of the pipes and regular wear and tear, thereby requiring a major repair;

WHEREAS, the Embassy's Annual Procurement Plan (APP) for 2018 includes the procurement of repair and maintenance works for the Embassy's furniture and fixture;

WHEREAS, the Embassy has requested and received price quotations from three (3) reputable suppliers, as follows:

WHEREAS, after careful consideration of these quotations, the BAC has identified A1 Sewer & Plumbing as the company that submitted the lowest responsive quotation for the required repair, with the price quotation of **Three Hundred Twenty Dollars only (US\$320.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00).

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, **RESOLVE** to **RECOMMEND** to the Head of Procuring Entity, the award of the contract for the repair of the Embassy's kitchen drainage, in favor of A1 Sewer & Plumbing, in the amount of **THREE HUNDRED TWENTY DOLLARS ONLY (US\$320.00)**.


