**RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF
THE CONTRACT FOR THE REPAIR AND MAINTENANCE OF THE
OFFICIAL SERVICE VAN (FORD TRANSIT) OF THE EMBASSY TO MOON
MERCEDES (Va Soklay)**

WHEREAS, the official service vehicle of the Embassy – a Ford Transit van with plate number CMD 61-019, encountered mechanical problems on 02 June 2018, requiring immediate repair of its clutch system:

WHEREAS, the Annual Procurement Plan (APP) for 2018 of the Embassy of the Philippines in Phnom Penh, includes the procurement of repair and maintenance works for the official vehicles of the Embassy;

WHEREAS, the Embassy requested and received quotations from three (3) different qualified auto repair shops for the abovementioned repair works, as follows:

COMPANY NAME	QUOTED PRICE
Moon Mercedes	US\$820.00
Garage Auto Cheang Hak	US\$850.00
Kin Mak Garage	US\$900.00

WHEREAS, after careful consideration of these quotations, the Embassy has identified Moon Mercedes (Va Soklay) as the car repair shop that submitted the lowest responsive quotation for the required mechanical repairs, with the price quotation of **Eight Hundred Twenty Dollars only (US\$820.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to Small Value Procurement provided the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00);

NOW THEREFORE, we, the members of the Bids and Awards Committee of the Embassy, **RESOLVE** to **RECOMMEND** to the Head of Procuring Entity the award of the contract for the procurement of repair and maintenance service for the Embassy's Service Van, **FORD TRANSIT with plate number CMD 61-019**, in favor of Moon Mercedes, in the amount of **EIGHT HUNDRED TWENTY DOLLARS ONLY (US\$820.00)**.


